In all its proceedings, the Intergroup Association observes the spirit of AA Traditions, taking great care that the Intergroup Association never becomes the seat of perilous wealth or power; that sufficient operating funds, plus a reserve be its prudent financial principal; that none of the Intergroup Association members shall ever be placed in a position of unqualified authority over any of the others; that all important decision be reached by discussion, vote and whenever possible, substantial unanimity; that no Intergroup Association action ever be personally punitive or an incitement to public controversy; that though the Intergroup Association may act for the service of AA Groups in the Northern Nevada area and parts of Northern California, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous, the Intergroup Association itself will always remain democratic in thought and action

NORTHERN NEVADA INTERGROUP

A Native American Legend

Recovery Step Five:

"Admitted to God, to ourselves, and to another human being the exact nature of our wrongs."



Unity Tradition Five:

"Each group has but one primary purpose—to carry its message to the alcoholic who still suffers."



Service Concept Five:

"Throughout our structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that minority opinion will be heard and petitions for the redress of personal grievances will be carefully considered."

Concept V: Right of Appeal

Throughout his writings on the Twelve Concepts our founder expresses an underlying principle on which the Society of Alcoholics Anonymous is based, that it always be democratic in spirit, thought and action. Maintaining a "Right of Appeal" is important to this. Appeal provides for a response when there is disagreement with any action, or when any procedure is thought to fall too far short of the democratic ideal Bill envisioned.

While at my first General Service Area Assembly I was surprised to find that taking a vote on a matter did not always bring an end to the discussion. After the vote was taken, the Chairperson kept the discussion open by asking whether anyone who had voted in the minority, the losing side, wanted to speak further. This was a purposeful and planned exercise of the right of appeal. It added assurance that all opinions were adequately heard, and had not been overrun by a hasty vote or an impatient majority. As I continued to attend Assemblies I witnessed several situations in which an expressed minority opinion changed the eventual outcome, different from the original majority vote, and led to a much better decision.

As Bill says it, "To increase the actual *spirit of democracy* by special deference to minority opinion is, we think, better than to follow blindly the rule which always insists on an unqualified dominance by a slight majority vote". Bill recognizes that a majority vote may not always lead to the best, fairest, most appropriate or right decision.

Applications of the right of appeal include the right to petition. This becomes important when any minority, or even a majority, feels that a decision was made by someone who may not have had the authority to make that decision, when a decision is made without adequate debate and discussion, or when the decision is felt to be wrong or not in the best interest of the whole of A.A. Bill says that in A.A.'s world services both appeal and petition have always been put to good use.

"Right of Appeal" includes the right of an A.A. employee or member to appeal and request a hearing regarding a personal grievance. One of the underlying principles of the right to appeal is that we respect everyone's experiences as well as what they have to say based on those experiences. Even if they might be wrong they have a right to be heard and, many times, they may have a better idea than what the majority thought best.

Some of the enemies of the spirit of democracy include impatience, apathy, self-seeking, uninformed or angry majorities, and the exercise of too much personal power. Bill says that A.A. has no room for any of these.

Bill reminds us in the text of Concept V that any alcoholic can be a member of A.A. the moment he says he is. He has a right to belong no matter what he thinks or believes. "Ours is indeed a large charter of minority privileges and liberties." The right of appeal is one method we have for assuring that these liberties and privileges are always respected and maintained as we work together in fellowship with one another.






My big fat taped-up Big Book

She held on to a copy for dear life...then she realized it was written for her



After nearly two decades of drinking, my life was at its lowest point. I was sick and tired of being sick and tired and didn't want to live that way one more day. That's when I saw a public service announcement that directed me to our sister program. I was 31.

Although I was still drinking, the people there suggested that I read the Big Book to better understand my husband, who was an active alcoholic. I paid 25 cents a week to buy that first Big Book (below) on an installment plan. I tucked the book away in the headboard of our bed so my husband wouldn't see it. Eventually, he found the book. He was furious and tore it up in three pieces. Livid that he would destroy this book in which my meager funds had been invested, I was determined not to let him get away with it. Every morning when he left for work, I took the book out of its new hiding place and taped the sections together, a page at a time. As I taped, I read. When I reached the third chapter, "More About Alcoholism," I began to identify with the description of an alcoholic and recognized parts of myself within the pages. Members had told me to read the book to better understand my alcoholic husband, however the book was now describing me. Could I possibly be an alcoholic? That question was the first step on my journey into sobriety. The taping continued one page at a time for weeks until the entire book was finished and was fanned out so wide that it couldn't be closed. I talked with my sponsor from our sister program about my dilemma, and she suggested that I talk with some AA women. This was the beginning of the end of my violent, 16-year alcoholic marriage, which had produced three children. My sobriety date, in 1972, was also the day I filed for divorce.

As instructed, I wrote my name and sobriety date inside the front cover and I was told that I never had to change that date. My last name has changed three times since then, but my sobriety date has never changed. I read that book one sentence at a time every day at first. Then, as my mind grew less foggy, I read entire paragraphs and eventually two pages a day and more, going from cover to cover. As I read, something changed in me. I was now focusing on my sobriety instead of his drinking.

That first year as a single, sober, alcoholic mother was a rocky one, with me hanging on one day at a time—sometimes one minute at a time—to my sobriety. Many nights were spent holding my Big Book for comfort while I slept. I was willing to go to any length to stay sober, even though I still questioned whether I was really an alcoholic. It took four years of not drinking, reading the book and doing service, along with whatever else was suggested, for me to fully concede to my innermost self that I was an alcoholic.

The Big Book told me that we have "ceased fighting anything or anyone—even alcohol." It also advised that, "practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics."

I believe everything in the Big Book is there for a reason and it's important to read the entire book, not only the first 164 pages. There are many precious gems found in the stories in the back, such as the last pages of "Freedom from Bondage," which I call the two-week prayer, which saved my first husband's life. The wonderful words in this story were my guide when making amends to that man. Years later, when he died, I actually cried. I continued reading that big, fat, taped-up book and carrying it to meetings until the beginning of my second year, when this gorgeous Yugoslavian man briefly came into my life. He took one look at my oversized Big Book and convinced me to throw it away and use the new Second Edition he had bought for me. That man is no longer in my life, but that new Big Book he bought me still is.

Forty-six years later, that book he gave me is about as fat as my first one. Its yellowed pages are held together with tape, the edges are frayed and the cover with my name and only sobriety date has separated from the binding. There are many multicolored, highlighted, underlined, circled and boxed areas throughout the book. The detached first few pages are tucked inside the zippered cover that holds this treasured publication with all the AA history and special notes garnered over the years that have been passed on to countless other alcoholics. In the chapter "Working With Others" it says, "If he shows interest, lend him your copy of this book." Being still selfish and self-centered, there is no way my book is going to be loaned or given away. It means too much to me. I'll gladly buy someone a book if they need one. Someone suggested having the book rebound, but that would mean having to put a new cover on it and that clearly would not work for me. I regret throwing the first book away, but at least it's still in my memory. Others have suggested getting rid of this second book and getting a new one, but I intend to keep working from it as long as there are still words on the pages. Recently after I spoke at a meeting, a young lady asked me if she could take a picture of my Second Edition Big Book. She had never seen anything quite like it before. My current sponsor strongly recommended I use a pristine Fourth Edition with no notes when going through the Steps with her. She wanted me to start with a fresh, open, teachable mind, and I complied. But my practice of studying, not simply reading, two pages every day from my big, fat, taped-up Big Book remains to this day. This book is my sobriety and sponsoring tool that keeps getting sharpened as I continue learning more and passing it on to others

Sponsor Relationships

Everybody needs somebody to work things out

ONE SPONSOR plus one group equals sobriety! That's what was suggested to me in my first week. However, I often saw some other newcomer claim four or five groups as home groups, pick a liberal, a moderate, and a conservative as sponsors, ask all three for advice, then do as he pleased. And he stayed sober! Which is the better way? As the Siamese monarch said in The King and I, "It's a puzzlement."

Rigid formulas for sobriety wear thin for me. They can get boring. I fell in love with Alcoholics Anonymous because our program is so malleable. The Steps, the Traditions, and the Twelve Concepts for world service all allow us complete autonomy as groups and freedom as individuals. The way one person works the program is not necessarily the way another does or, indeed, should.

Still--I pretty much had one sponsor and one group at a time. Hindsight indicates that this was good for me, though I know quite well that there are other ways.

In a small town, there may be only one group. In a large city, however, it is possible to walk to a half-dozen groups, and most of us do. I ended up belonging to one group and visiting several others. I really didn't have time for more than one home group. I did all the chores that needed doing. I held group offices. I spoke. I did Twelfth Step work. I helped to plan the group's anniversary meetings, and I attended meetings of our local general service committee and intergroup. I knew all the members of my group and most of their families. By the time I visited another group, all I wanted to do was relax and listen.

For me, the AA home group was an essential experience, part of my growing-up. I knew the other members were on my side and would miss me if I wasn't there. In that group, I learned how to behave with people as a sober man. It took time. We had problems and arguments and survived sober, to love one another more. Some people seem to sort of "do AA this year," the way they would take up needlepoint or tennis. AA for me is not a hobby or sport. It is, admittedly and unashamedly, the center of my life. I had to go out into that life from the bosom of a family. One family.

I can laugh and joke with a changing crowd, but I need a familiar few to hurt and cry with. I did a lot of hurting the first couple of years. The first sponsor I had picked me. He swooped down on me and said, "Stick around, kid. You're in the right place." He had me making coffee and driving the gang to a speaking commitment in Connecticut in my first month. Connecticut! I hadn't gotten out of Brooklyn in ten years. I bragged about it as if I'd been invited to the French Riviera. At that stage, I needed someone to think for me. and my first sponsor did.

A whole series of other wonderful AAs befriended me along the way. Some had even less sobriety than I had. That was okay by me. If the Higher Power gave me answers through a newer person, I accepted them.

In my AA travels, I picked up a confidant who was particularly loving and kind. He was a tall, gangling guy, always in casual clothes, with a twinkle in his eyes and twenty-two years on me. He was a grandfather, with a lot of common sense. I met his mother, sisters, and grandchildren. We went to beach parties and movies together and played golf.

Tom was the greatest teacher I ever had. Do you want to know one of his greatest teaching tools? He shared. It was that simple. Tom not only shared his family and life and joys, but privileged me by sharing his troubles as well. I saw firsthand how an adult could be man enough to say honestly, "Ouch! I'm hurting!" In the process, I learned how to confide, use the telephone, and relish the Fifth Step.

Tom knew as much about me as I knew about myself--or probably even more than I could bear to admit about myself at the time. He once pinned me to the wall by saying, "Ed, you have an absolute genius for talking around a problem. Some day, you'll get honest and call a spade a spade." Eventually, I did. He was a gentle man and allowed me to grow up in my own time. He was great with tender egos, patient beyond belief.

One day I went up to him and said, "Tom, I never asked anyone to be my sponsor. You're it--okay?" I felt foolish.

He beamed his best smile and said, "Uh, sure, Ed. We'll work it one day at a time. But tell me--what do you think it is we've been doing for the last eighteen months?"

Tom died suddenly one day. Sober. I knew his view of death, so I was not unnerved. To him, death was just another state of being. He had helped me overcome my gnawing fear that everything ended when we died. You see, he had not just backslapped me and sent me on my way--he had shared in the fullest sense of the word.

That kind of sharing usually is a once-in-a-lifetime thing. If you have it more than once, you are fortunate beyond belief. For a spell, I floated in the program without a sponsor. I had never really liked the word, anyway. Because of my ego, "sponsor" sounded ominous. I heard sober people use other words, like "coach," and didn't care much for them, either. But I also kept hearing speakers at meetings talk lovingly about their sponsors of twenty or twenty-five years ago.

Today, I have another close AA friend, a man who is in the same profession I am, has been sober a little longer, and has great balance in his way of life. I have filled him in on my past. I want someone who knows me near at hand. I want to be able to call any time and say, "Hey, Jerry, here's my problem." I'd rather not have to fill out a questionnaire first. I want Jerry to be able to give me advice based on what he knows about me--the whole story, not meaningless patches with meaningful gaps in between. Believe me, it took guts for me to fill Jerry in on "the great I," but it was good for me. It helped keep my ego in line. For me, this is an essential effort that must be made continually.

It is obvious that the word "sponsor" has a very special meaning (or meanings) to me. It changes as I change. My first sponsor helped me over the bumps. I needed a friend then very much. Later might have been too late. I am glad he didn't wait until I picked him. Then I needed a guide-Tom--who would let me find myself as painlessly as possible. Now I need someone--Jerry--to keep my Tenth Step inventory in order. I have always found the right person when I needed him most.

I have spoken to several people who think the patterns of sponsorship are changing in general. They claim that some new people are leery of commitment to a sponsor, just as some older members are leery of commitment to a newcomer. Fear of commitment can take exasperating turns. Here's what happened to a newcomer I know. His sponsor said he was busy, but would meet the newcomer any time he called. So the newcomer did call one day and was told to give more notice. On the next call, the newcomer asked to see the sponsor fourteen days later. The older man said that he followed the AA program and could not project that far in the future! Sounds silly, but it happened.

Some AAs get shy about sponsoring people in and out of hospitals, especially at large detoxification centers. One or two abrupt rejections from a patient leave them doubtful about doing this type of Twelfth Step work ever again. I think we must remember that we carry the message and not the drunk. When a person is hospitalized, it's a golden opportunity for us, and we should not stop trying. No matter how outside circumstances change, most AAs feel that the new person still needs a friend in the beginning and that the older member still needs the spiritual experience of watching a new person get sober and grow.

My own experience as a sponsor has varied, I held on to one guy too long. I never will make that mistake again. A wise man said a sponsor should, just, for a time, do things for a new person that he can't do for himself--and then turn him over to the conscience of the group. Sounds to me like a fine way to avoid any fears that either side may have of being possessive or being possessed.

And I've had the opposite experience--being asked to sponsor, then never seeing that newcomer again. I think some people ask me just because they think they should have an official sponsor, but rarely do they need me.

Still, there are people out there whom I have helped, I believe. I advised them to lean on AA, since that's what I lean on for independence and a fear-free life. These are my happiest sponsor relationships. There are many other AAs whom I share with. They don't call me sponsor, but they work out problems with me, and I do the same with them. I am not good as an authority figure who has all the answers. I am just fine as a sober drunk not too proud to admit I had a lousy night last night.

Now that I've reflected on sponsorship and its changing nature, I do not feel it is such a puzzlement after all. Each AA, as newcomer or as sponsor, must find the right method for himself or for herself. For this AA, the right formula remains: One sponsor plus one group equals sobriety.

Individuals may request an electronic copy by providing an e-mail address coupled with a minimal donation. Contact the CoCenOf for details. For hard copies, provide mailing address and the fee as designated by the Central Office. The CoCenOf removes those names from the mailing list upon receipt of returned Bracers from United States Post Office. 
