Motion to vote this tabled as Reps take info back to groups describing the Prudent Reserve shortfall, that there are not funds available.

New Business: The Back Room Group had motioned that Operating Procedures be followed with regard to excess funds over 30 days. Treasurer and Steering Committee reviewed this and motioned to change the Ops Procedures to 2 months funds held so CO is not having to go back and forth to bank to withdraw from CDs etc. Up/Down vote called for by NNIG Reps (required by Ops 18.3). Unanimous to change this Ops Procedure 10.7.6 to 2 months.

Chair advises that the Steering Committee will have a preliminary Budget prepared for review by November to finalized in February. All chairs to

provide their 2020 Budget of funds needed to Steering Committee not later than 12/1/19. If anyone needs help, contact Steering Committee.

Paul M. has asked all Reps to encourage groups to change contribution to CO by +1%. This to make up for expected shortfall in Group Contributions.
