In all its proceedings, the Intergroup Association observes the spirit of AA Traditions, taking great care that the Intergroup Association never becomes the seat of perilous wealth or power; that sufficient operating funds, plus a reserve be its prudent financial principal; that none of the Intergroup Association members shall ever be placed in a position of unqualified authority over any of the others; that all important decision be reached by discussion, vote and whenever possible, substantial unanimity; that no Intergroup Association action ever be personally punitive or an incitement to public controversy; that though the Intergroup Association may act for the service of AA Groups in the Northern Nevada area and parts of Northern California, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous, the Intergroup Association itself will always remain democratic in thought and action.

NORTHERN NEVADA INTERGROUP

"Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward."

Our whole A.A. program is securely founded on the principle of humility--that is to say, perspective. Which implies, among other things, that we relate ourselves rightly to God and to our fellows; that we each see ourselves as we really are--"a small part of a great whole." Seeing our fellows thus, we shall enjoy group harmony. That is why A.A. Tradition can confidently state, "Our common welfare comes first."

"Does this mean," some will ask, "that in A.A. the individual doesn't count too much? Is he to be swallowed up, dominated by the group?"

No, it doesn't seem to work out that way. Perhaps there is no society on earth more solicitous of personal welfare, more careful to grant the individual the greatest possible liberty of belief and action. Alcoholics Anonymous has no "musts." Few A.A. groups impose penalties on anyone for non-conformity. We do suggest, but we don't discipline. Instead, compliance or non-compliance with any principle of A.A. is a matter for the conscience of the individual; he is the judge of his own conduct. Those words of old time, "Judge not," we observe most literally.

"But," some will argue, "if A.A. has no authority to govern its individual members or groups, how shall it ever be sure that the common welfare does come first? How is it possible to be governed without a government? If everyone can do as he pleases, how can you have aught but anarchy?"

The answer seems to be that we A.A.s cannot really do as we please, though there is no constituted human authority to restrain us. Actually, our common welfare is protected by powerful safeguards. The moment any action seriously threatens the common welfare, group opinion mobilizes to remind us; our conscience begins to complain. If one persists, he may become so disturbed as to get drunk; alcohol gives him a beating. Group opinion shows him that he is off the beam, his own conscience tells him that he is dead wrong, and, if he goes too far, Barleycorn brings him real conviction.

So it is we learn that in matters deeply affecting the group as a whole, "our common welfare comes first." Rebellion ceases and cooperation begins because it must; we have disciplined ourselves.

Eventually, of course, we cooperate because we really wish to; we see that without substantial unity there can be no A.A., and that without A.A. there can be little lasting recovery for anyone. We gladly set aside personal ambitions whenever these might harm A.A. We humbly confess that we are but "a small part of a great whole."

The Twelve Concepts for World Service How Bill W. explained the spiritual principles that undergird A.A.'s structure and how the parts work together.

The Twelve Concepts for World Service How Bill W. explained the spiritual principles that undergird A.A.'s structure and how the parts work together. This is a pamphlet about the Concepts; it is NOT the Concepts themselves. They are found in the book The A.A. Service Manual/Twelve Concepts for World Service, and should be read by every "trusted servant." As A.A. grew up, it began with the groups — first only a few, then hundreds and then thousands. Very early an Alcoholic Foundation, later renamed The General Service Board, was formed to be responsible for our affairs. And with Dr. Bob's death and Bill's facing up to his own mortality, a General Service Conference assumed the leadership which had fallen to the co-founders. Meanwhile, a tiny publishing operation and service office had grown in size and importance to the Fellowship, and a monthly journal, the AA Grapevine, was being published. Which of these entities was supposed to do what? Little wonder there was confusion! What was their relationship? Who was in charge? What were their responsibilities — and what were their rights? Bill W. himself was sometimes part of the pulling and hauling that took place, and so he saw the need to "reduce to writing" his concepts of the "why" of the whole structure, the lessons to be drawn from experience, the relationships and, above all, the spiritual principles. As Bill set them down, the Twelve Concepts are a potpourri: Concepts III through V, IX and XII deal with spiritual principles; the remainder, though they have spiritual overtones, are devoted to describing the relationship of the various service entities and how they work together. What follows in this pamphlet is an illustrated introduction to the Twelve Concepts. If it is answers or guidance you are seeking, go to the Concepts themselves. Throughout this pamphlet, wording from the Twelve Concepts themselves (subject to some editing for clarity) is indicated by quotation marks; the rest of the text is either descriptive or explanatory.

Concept I Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

Alcoholics Anonymous has been called an upside-down organization because the "ultimate responsibility and final authority for . . . world services" resides with the groups — rather than with the trustees of the General Service Board or the General Service Office in New York. In Concept I, Bill traces how this came to be. The first step in 1938 was "the creation of a trusteeship," first called the Alcoholic Foundation, renamed in 1954 the General Service Board. Why? To perform the services the groups could not do for themselves: e.g., uniform literature, uniform public information about A.A., helping new groups get started, sharing with them the experience of established groups, handling pleas for help, publishing a national magazine, and carrying the message in other languages and in other countries. A service office was formed to carry on these functions under the board's direction. Both the board and the office looked to the cofounders, Bill and Dr. Bob, for policy leadership. In the midst of the "exuberant success" of early A.A., Dr. Bob became fatally ill and Bill asked, "When Dr. Bob and I are gone, who would then advise the trustees and the office?" The answer, Bill felt, was to be found in the collective conscience of the A.A. groups. But how could the autonomous. widely scattered groups exercise such a responsibility?

Over great resistance by trustees and members devoted to the status quo, Bill managed to "sell" the idea of calling an A.A. General Service Conference (see Concept II), and eleven years later Bill was able to declare, "The results of the Conference have exceeded our highest expectations." This Concept is rooted in Tradition Two, which states: "For our group purpose there is but one ultimate authority — a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern." The principles of Tradition Two are crystal-clear, Bill asserts: "The A.A. groups are to be the final authority; their leaders are to be entrusted with delegated responsibilities only." The outside world cannot imagine an organization run this way, but Bill calls it "a spiritualized society characterized by enough enlightenment, enough responsibility, and enough love of man and of God to insure that our democracy of world service will work "

STEP ONE -THE MOST OFTEN MISQUOTED STEP OF A.A.'S 12 STEPS!

We sit around in meetings emphasizing the importance of a complete and perfect First Step – and it's Step One – that is one of the most misquoted Steps of the 12 Steps.

The word "and" is NOT in Step One.

I hear it over and over again "We admitted that we were powerless over alcohol *AND* our lives had become unmanageable."

That's NOT Step 1.

Step 1 is "We admitted we were powerless over alcohol – that our lives had become unmanageable." $\,$

Contrary to what is popularly quoted – and, I believe its fuel that feeds the resistance and confusion about Step One – **Step 1 is NOT a** "two part" Step.

Step One is an admission of alcoholism. (See page 30 of the Big Book).

It is an acknowledgement that we have become convinced in our inner-most selves that we are alcoholics.

I made the error, also – for many years, thinking that "Step One is a two part Step." It isn't.

When I read the descriptions of "what an alcoholic is" in the Big Book – I have yet to find any reference that "and an unmanageable life" has anything to do – with whether or not a person is alcoholic or non-alcoholic. It just isn't there.

For me – when I was new in A.A., part of the reason I was confused and could not become convinced that I was alcoholic – was because I was not convinced that "my life was unmanageable" – like I was hearing about it in A.A. meetings.

Therefore, I concluded that "if my life is not unmanageable – then, I must not be an alcoholic."

So... what did I do? I continued drinking and letting my life get progressively more screwed up, and allowing my alcoholism to progress without treating it – until I could say "my life is unmanageable."

Had I known the proper description of an alcoholic – and realized that the "and my life had become unmanageable" was not part of the description of an alcoholic – I might have had a better chance of grasping the concept of alcoholism.

WHY IS THIS IMPORTANT?

I believe that the reasons that it is important are:

- 1. It's wrong. And, it's confusing.
- 2. Using the word "and" is adding a "condition" to alcoholism, that just isn't there.
- 3. If we are ever to succeed in helping the still suffering alcoholics to "raise their bottom" the easiest way to do that would be to admit to our error and correct it.
- 4. We can better understand the meaning of Step One by looking at it as it was written.

Notice in #4 above - where I used the dash.

To substitute the dash in #4 above, the thought and the sentence – wouldn't make sense. Or you could do it with the sentence preceding this one! Substitute the word "and" for the "dash" and it makes no sense.

Take a look at Step One. Do you see the word "and"? It isn't there.

What we have is a "hyphen" -- a "dash".

In our English language, when a hyphen is not used to break up a word, it is used to connect a thought or phrase.

Often, we refer to it as a "dash".

A dash is the mark or sign (—) used to note an abrupt break or pause in a sentence or hesitation in an utterance, to begin and end a parenthetic word, phrase, or clause, to indicate the omission of letters or words, to divide a line, to substitute for certain uses of the colon, and to separate any of various elements of a sentence or series of sentences, as a question from its answer.

From American Heritage New Dictionary of Cultural Literacy, Third Edition - dash

A punctuation mark (—) used to indicate a sudden break in thought, to set off parenthetical material, or to take the place of such expressions as that is and namely: "He's running for reelection — if he lives until then"; "Very few people in this class — three, to be exact — have completed their projects"; "She joined the chorus for only one reason — she loves to sing." In the last example, where the parenthetical material comes at the end of the sentence rather than in the middle, a colon could be used instead of the dash.

Step One: "We admitted we were powerless over alcohol – that our lives had become unmanageable."

If I were to paraphrase Step One, as it is written, using the dash as a concluding thought, rather than an "and" -- I could say "I admitted that I am powerless over staying sober -- because I cannot manage to leave alcohol entirely alone." Or – "We admitted that we were powerless over alcohol – we could not manage to leave alcohol entirely alone." The insanity of the first drink. The obsession that prevents us from leaving alcohol alone – while we are entirely sober!

This, then means – that "my life had become unmanageable" – regardless if I was drinking or sober – because I cannot manage to leave alcohol entirely alone. We know from the Doctor's Opinion, and from our own experience – that it is not safe for us alcoholics to use alcohol in any form at all.

If it is unsafe for us to use alcohol in any form at all, and we cannot manage to leave alcohol entirely alone – we are powerless over drinking alcohol. Simple. Complete. No argument.

Those thoughts are more in line with our Big Book's description of the alcoholic in Chapter Three More about alcoholism and in Chapter Four, We Agnostics.
